Proposed 2019-2020 Amendments to the GFWC II Antioch Woman's Club Bylaws

ARTICLE II – OBJECT

AMENDMENT: Change OBJECT to MISSION

SECTION 1 - Reads: The objectives of the Club are intellectual growth and unity of effort toward civic improvement.

AMENDMENT: Delete Section 1

New **SECTION 1** – The mission of GFWC Illinois Antioch Woman's Club is to provide intellectual growth and unity of effort toward civic improvement – a philanthropic organization dedicated to enhancing the lives of others through volunteer service. We are a 501 (c) (3) tax exempt organization.

RATIONALE: Clarification

ARTICLE V – DUTIES OF CHAIRMEN OF STANDING COMMITTEES

SECTION 5 – Reads: The Home Life/Health Chairman's duties are to encourage members to understand and participate etc. Winchester House and Card Ambassador etc.

AMENDMENT: Delete Winchester House and insert nursing home activities.

RATIONALE: Chairman will be working with various nursing homes in the area.

ADD: SECTION 11 – The Program Chairman shall select programs for the Club.

RATIONALE: There being no Program Bureau, the Program Chairman will be elected with the rest of the Committee Chairman.

ARTICLE VII – NOMINATIONS AND ELECTIONS

DELETE SECTION 1

NEW:

(a) Will become new SECTION 1

(b) Will become new SECTION 2

RATIONALE: See Article V – Section 11

ARTICLE VIII – MEMBERSHIP

SECTION 3 (c) Reads: Honorary members are exempt from paying dues but are not eligible to vote etc. Delete but and add and are not eligible to vote, etc.

RATIONALE: Housekeeping

ARTICLE IX – DUES

SECTION 3 – Reads: The current expenses of the Club shall be paid from annual dues and such other money as may be raised by special efforts of the Club. The Club will pay expenses for the President, President-Elect to go to the GFWC IL Annual Convention and will concur with the yearly amount as budgeted for the Convention.

AMENDMENT: The current expenses of the Club shall be paid from annual dues and other money raised by special efforts of the Club. The Club will pay expenses for the President, President-Elect, or a substitute as selected by the President, to go to the GFWC II Annual Convention and will concur with the yearly amount as budgeted for the Convention.
